- You agree to keep the data submitted for India Rankings 2018 and prescribed formats archived on your institute website for a period of three years post data capturing system.
- You agree to cooperate in case your institute is approached for carrying out physical check. Non-cooperation may lead to debarring the institution from participation in the ranking exercise.
